

**PROCEEDING OF 5<sup>th</sup> GENERAL BODY MEETING OF AOPMEF HELD ON**

The **fifth General Body Meeting** of All Odisha Private Medical Establishment Forum was held at 11 AM on 20<sup>th</sup> May, 2018 in the Main Hall of IMA Institute, Bhubaneswar. The meeting was chaired by Dr. Ajoy Kumar Mishra, President, Vice-Presidents Dr. Jagannath Mohapatra, Dr. Krupasindhu Panda, Vice-President and Spokes Person, Dr. Subrat Jena, Dr. Indramani Jena, Secretary and Dr. Debadatta Kumar Sahu, Treasurer, AOPMEF were also on the dais. Among them, our invited guest was Dr. Santosh Kumar Mishra, IMA Odisha State President.

The meeting was attended by 90 members from different corners of Odisha. In addition to our members and district association executives, special invitees like Secretary, Indian Dental Association, Odisha Branch, Secretary, Indian Association of Physiotherapy, Odisha Branch, Member, Radiological Association, Odisha and delegates of Corporate Hospitals, Private Medical Colleges, Bhubaneswar were present.

1. Dr. Ajoy Kumar Mishra, welcomed all members and delegates and depicted the concern of AOPMEF as registration and renewal is impossible since 2014. The only target of the Forum is Cease Work and we will undertake it in spite of people's discomforts, as we are explaining them sufficient ahead of date.
2. Dr. Subrat Jena, Vice-President and Spokes Person of the Forum presented the importance of Private Sector in health care scenario of the State as per estimations of WHO and World Bank. But Odisha State Administration has been apathetic and controversial and even inimical to Private run healthcare institutions in registering, renewing and fostering them.
3. Dr. Jagannath Mohapatra, Vice-President of the Forum advised how to have integrity and cooperation in our attempt to raise the Cease-Work. Our unity will be the backbone of our success.
4. Dr. Santosh Kumar Mishra, President, Odisha State Branch of IMA spoke on the achievements of IMA on similar disturbances in Maharashtra, Karnataka and

Haryana. He emphasized that the district tributaries of IMA have been streamlined to associate with the ongoing agitation of AOPMEF.

5. Dr. Krupasindhu Panda described that public must be well informed, involved and have a say in this agitation. He narrated the scenario of past agitations and how will be coming cease work.
6. Dr. Debadatta Sahu, the Treasurer of the Forum discussed on more and more CEs enrolling all the Members of the Forum by effort of Zonal and District Associations.
7. There was good participation by executives and members from floor with expression of preparedness in their respective areas and suggestions of the movement in detail. Dr. Patra, Secretary, Indian Dental Association, Odisha Branch, Secretary, Indian Association of Physiotherapy, Odisha Branch, Dr. R.R.Mohanty, Member, Radiological Association, Odisha assured their full cooperation and assured the closure of their CEs on cease-work day. Dr. S. Mishra, Enterpreneur, Sun Shine Corporate Hospital, Dr. Rabindra Kumar Pradhan, Dr. Biswanath Patnaik, Dr. H. Nayak and many others expressed their state of preparedness and future programmes.
8. Dr. Indramani Jena, Secretary of the Forum expressed that we have intimated the cease-work news to all authorities from CM, HM, Chief Secretary, Health Secretary, DMET, DG Police, all Collectors as available in website of Government of Odisha. Our programme for cease-work is adequate propagation of the news through posters (not only on CEs, but bigger ones to be hung at public sites), holding meetings and contacting conscious people who can anchor our purpose. On the very day of the cease-work, all CEs are to be closed for routine and emergency (barring indoors, which will run inside) and staff at gate directing cases to Government hospitals. Many of the staff will be sent to proposed place as decided to start the rally to Ministers / Collectors / CDMOs. The rally will proceed with a Placard and even a loud speaker announcing the purpose of rally. Rally will present a memorandum and will hold a meeting and press conference there. Contents of the placard and memorandum will be intimated shortly.
9. Press Conference was conducted with many electronic and print media.

## MEMORANDUM OF ALL ODISHA MEDICAL ESTABLISHMENT FORUM

Dear Sir,

We, members of AOPMEF consist of all private entrepreneurs of private hospitals, diagnostic centres provide major load of health care burden of the State. Our smooth functioning needs our registration and realistic approach in field of our service.

We have faced serious lapses in matter of registration and renewal since 2014. New CE Rule has not been acceptable as huge sum of 5 years fee deposit is stated to be non-refundable on the event of lack of any required certificate, the NOC fire is impossible till today and no rule has been made by DG Fire for existing Clinical Establishments before Fire Rule of 2017.

We put forth before you the following –

1. Registration and Renewal of Clinical Establishment without any delay pending since 2014
2. Provision of Security in our Clinical establishments
3. Classification of Private Hospitals as small, medium or big. The smaller ones provide healthcare at affordable rates for the State and should be exempted from sophisticated Clinical Establishment provisions meant for big hospitals.
4. No coercion to treat at impossible low rate, CGHS rate is an imposition and is not possible in a private setting of maintaining private structural and manpower specifications of CE Act.
5. Constitution of Odisha State Clinical Establishment Council has become bare necessity for Odisha. Many other states manage their CEs with State CEC where the participation of our representatives will be part.

We need your prompt solution of the matter.
